Re.: Non participation in RallyRACC Catalunya-Costa Daurada – Rally de España 2011 of SWRC crew No. 29.

The Entrant TURAN MOTORSPORT has registered with the FIA as a Team to take part with one car in the 2011 FIA Super 2000 World Rally Championship and has nominated the Rally de España as one of its events to score points.

The Team has already participated this year in the following events: Rally Jordan, Rally Italy, Rally Greece, Rally Finland, Rally Germany and Rally France. The next nominated event was the 2011 Rally Spain.

The Stewards received a copy of the correspondence between the team manager of the Entrant TURAN MOTORSPORT, the FIA and the SWRC Co-ordinator Ninni Russo.

The Entrant advised that the team would not be able to be present at the upcoming RACC Rally in Spain due to health problems of the co-driver. A medical documentation would be sent. The medical certificates and X-rays were received at the Rally of Spain Headquarters on Wednesday, 19 October 2011.

The medical information submitted by the Entrant was examined by the FIA Medical Delegate Dr. Jean Duby at the request of the Stewards.

Dr. Duby, after studying the medical evidence, advised the Stewards that he considered the injury to have been sustained several years ago and that even though the co-drivers condition may have deteriorated due to another incident in September 2011, he could not definitely confirm this to be a case of “force majeure”.

The Stewards consider that the failure of the Entrant and Team TURAN MOTORSPORT to take part in the 2011 Rally de España cannot be considered as a case for “force majeure” as per Article 8.4 of the 2011 FIA World Rally Championship Sporting Regulations.

Irrespective of the medical condition of the co-driver, the Entrant and Team TURAN MOTORSPORT did have enough time to arrange for a co-driver to replace the one entered for the 2011 Rally of Spain or to request the replacement of both driver and co-driver of the crew originally entered for the Rally of Spain.


The Stewards after deliberation, having studied the written submissions and having decided that this is not a case of “force majeure”

DECIDE


- To apply Article 8.4.1 of the 2011 FIA WRC Sporting Regulations and pronounce the sentence of exclusion from the 2011 FIA Super 2000 World Rally Championship.

- To inflict a fine of € 3,000 on the Entrant TURAN MOTORSPORT.
- The Entrant TURAN MOTORSPORT is referred to its ASN with the recommendation to apply suspension in the case of any delay in the payment of the above fine, as provided for in Article 157 of the 2011 FIA International Sporting Code.


The Entrant is reminded of its right of appeal.


