The Stewards received a report from the FIA Technical Delegate on final scrutineering concerning car No. 42.

The report stated that the complete wishbone/arms were weighed as follows:

Right = 3296g

Left = 3218g

The maximum allowed weight as specified in Homologation Form A-5748 is 3190.95 g, inclusive of the permitted tolerance of 5%.

The parts were sealed by the scrutineers.

The Stewards then heard at 19.55 hrs the Competitor's representative, Mr. Tamás Tagai, Technical Director, and Ms. Virag Pergel, Team Manager, in the presence of the FIA Technical Delegate and his assistant Luca Gibello.

Mr. Tamás Tagai stated that they had themselves been at final scrutineering and confirmed that the overweight of the parts was not in question. They informed that they had bought the parts from their supplier and that they had not checked the weight before fitting them into their car for competing in RallyRACC-52 Catalunya-Costa Daurada-Rally de España 2016.


They further stated that there was nothing else to add from their side.

The Stewards consider that car No. 42 is not in conformity with its Homologation Form and that a breach of Article 4.2 of the 2016 FIA WRC Sporting Regulations and Article 10.3.3 of the 2016 FIA International Sporting Code has been committed and therefore, under Article 27.2.1 of the 2016 FIA WRC Sporting Regulations, and after due deliberation

#### DECIDE

- To impose, in application of Article 12.3.1.h of the 2016 FIA International Sporting Code, **a drop of 19 places in the Final Official Classification of the rally, thus a drop of 5 positions in the WRC2 classification, onto the Competitor.**
- This drop of positions in the classification is expressed in terms of **a time penalty of 25 minutes.**

The Competitor is reminded of its right to appeal.
