The Stewards, having received a report from the FIA Technical Delegate on final scrutineering, summoned a representative of the above competitor, have considered the following matter and determine the following:

Facts

The top of the radiator was modified and was therefore not complying with the homologated part.

Offence

Art. 10.3.3 of the 2019 FIA International Sporting Code and

Art. 261-02-3 of Appendix J to the 2019 FIA International Sporting Code

Decision

Fine of EUR 10,000 on Citroen Racing

Reason

The Stewards heard from the competitor No. 56 representative, Mr. Vincent Ducher and Citroen Racing's representatives, Mr. Jean Francois Grandclaudon and Mr. Didier Clement, on Sunday, 27.10.2019 at 21:00 hrs. The FIA Technical Delegate, Mr. Jérôme Toquet and his assistant Mr. Mathieu Rougnon were also present.

Mr Ducher stated that car No. 56 had suffered an accident and to repair the car they had ordered new parts, including this radiator. In order to fit the new part in place, they needed to modify it.

Mr. Grandclaudon explained that they send the new parts to their customers as standard part. The exact instructions on how this radiator is allowed to be modified in order to comply with the homologation form were not sent to the customer. He admitted their mistake.

After due deliberation, the Stewards conclude that this breach is fully ascribable to Citroen Racing. Therefore, under Article 12.4.1 in conjunction with Article 12.2.1 of the 2019 FIA International Sporting Code, the penalty is imposed on Citroen Racing.

Under the given circumstances, no further action is taken against the competitor Eric Camilli.
